

Accessibility Policy:Customer Service Standard

Providing Goods and Services to People with Disabilities

The Ontario Police Arbitration and Adjudication Commission's (OPAAC) Accessibility Policy: Customer Service Standard

This policy is adopted pursuant to the Accessibility for Ontarians with Disabilities Act, 2005. The Ontario Police Arbitration and Adjudication Commission (OPAAC) is committed to meeting the customer service standards set out in the Act and its regulations to encourage good practices which exceed the minimum customer service requirements.

Requesting Accessible Services

A person who has a special need may request an accommodation with respect to our services as instructed in our first contact email. The request should be made as soon as possible at the beginning of the process of requesting conciliation, mediation-arbitration or adjudication services. We will assess the request on a case-by-case basis and make our best efforts to respond to it effectively and in accordance with the principles established under the Accessibility for Ontarians with Disabilities Act, 2005, and the Ontario Human Rights Code.

When it is not practicable to incorporate accessibility design, criteria and features when procuring or acquiring goods, services or facilities, the Ontario Police Arbitration and Adjudication Commission will document an explanation and provide it upon request.

Assistive Devices

We will ensure that staff is familiar with various assistive devices that may be used by customers with disabilities while accessing our goods or services, and how to properly accommodate those needs. We welcome people with disabilities and their service animals. Service animals are allowed on the parts of our premises that are open to the public. A person with a disability who is accompanied by a support person will be allowed to have that person accompany them on our premises.

Communication

The Ontario Police Arbitration and Adjudication Commission is committed to meeting the communications needs of people. Staff will communicate in a manner enabling people with disabilities to communicate effectively for purposes of requesting, using, and receiving our facilities and services.

OPAAC is committed to providing a fully accessible telephone service. If telephone communication is not suitable to someone seeking our services, we will offer to communicate by alternate means of communication such as email. We are committed to

providing accessible adjudication decisions, arbitration awards, collective agreements, application forms and/or documents about our mandate. Upon request these documents may be provided in alternate formats including hard copy, large print, email, electronic versions, etc.

The Ontario Police Arbitration and Adjudication Commission has worked with Justice Technology Services on creating a website that conforms to the World Wide Web Consortium Web Content Accessibility Guidelines (WCAG) 2.0, Level AA. The OPAAC "Contact Us" page clearly notifies the public about the availability of accessible formats and communications which are available upon request.

Training

Every person who deals with members of the public or other third parties on behalf of the Ontario Police Arbitration and Adjudication Commission, whether the person does so as an employee, agent, volunteer or otherwise, will receive information and training about the provision of our goods or services to persons with disabilities. The Ontario Police Arbitration and Adjudication Commission will provide employees, and other affiliated members with information on Ontario's accessibility laws and on the Human Rights Code as it relates to people with disabilities. Training will be provided in a way that best suits the duties of employees, and other members.

The training will cover:

- A review of the purposes of the Accessibility for Ontarians with Disabilities Act, 2005 and the requirements of the customer service standard;
- How to interact and communicate with persons with various types of disability;
- How to interact with persons with disabilities who use an assistive device or require the assistance of a guide dog or other service animal or the assistance of a support person;
- How to use equipment or devices available on the provider's premises or otherwise provided by the provider that may help with the provision of goods or services to a person with a disability;
- What to do if a person with a disability is having difficulty in accessing our website, awards/decisions, policy documents, hearing rooms, or requires alternate format for submitting application and making meeting arrangements.

The following training courses are mandatory for employees within one month of hiring:

 Information and Communications Standards (eCourse)
- CPCT-Respectful Workplace Policy and the WDHP Program: Digital Awareness Module
- CPCT-SafeSmart for Employees (eCourse)
- CPCT-Working Together The OHRC and the AODA (Video)
- CPCT-Workplace Violence Prevention (eCourse)
- Cyber Security Basics Information Classification (eCourse)
- Cyber Security Basics: Combatting Cyber Threats (eCourse)

For Members or Staff without access to the OPS Learning Centre, the following training materials are for mandatory review within one month of hiring:

- <u>Serve-Ability: Transforming Ontario's Customer Service Online course</u>
- OPAAC's Customer Service Standard & other relevant policies

Every person who participates in developing the Ontario Police Arbitration and Adjudication Commission's policies, practices and procedures governing the provision of goods or services to members of the public or other third parties must also receive the above noted training.

Any new employee must complete the mandatory training courses within the first month of hiring. Any new Committee Members or third-party agent will also receive training materials to be completed and reviewed within the first month of appointment.

Training will be provided on an ongoing basis in connection with changes to the policies, practices and procedures governing the provision of goods or services to persons with disabilities. Dates on which training took place and the individuals who participated will be recorded in individual employee files. Training resources within the Ministry of the Solicitor General and/or other government resources are utilized to ensure employees are provided with the training needed to meet Ontario accessibility laws on an ongoing basis.

Feedback process

Our goal is to meet the expectations of people with disabilities who use our services. Comments regarding how well those expectations are being met are welcome and appreciated.

Feedback regarding the way we provide services to people with disabilities may be made in person, by telephone, in writing or by e-mail. If one of these methods is not suitable, a customer may request another method by contacting the Ontario Police Arbitration and Adjudication Commission. We expect to respond to comments within 5 business days of their receipt.
